Birth certificate or passport of student

Australian Childhood Immunisation Register (ACIR) Immunisation History Statement

(Only required for students enrolling in NSW Government primary schools for the first time)

Temporary Residents

(Please bring all related visa documents for both student and parent)

Residency Status

(If both parents are born overseas, one parent will need to provide an Australian passport or citizenship papers)

In addition:

If your child is the subject of family law matters, you will need to provide:

Copies of any family law, other relevant court orders or Out of Home Care placement details

If your child has health, disability or other support needs, you will need to provide:

Copies of medical/healthcare or emergency action plans issued by your doctor

Evidence of any disability or other support needs, including any learning and support plans

Does your child have any medical needs, for example asthma, severe allergies, anaphylaxis, diabetes or epilepsy?

If **Yes**, parents need to supply information for medical needs such as an individual asthma action plan, an ASCIA Action Plan for anaphylaxis/allergy or a management plan from a doctor for diabetes. These plans need to be issued & signed by a doctor with a review date.

Is the child attending any professional support services, for example speech therapy, occupational therapy?

If **Yes**, parents need to supply details of the provider and the type of support being received along with copies of any reports.
